One should not merely focus on the experts attached to the acceptance of online learning but should also take account of developing and enhancing the quality of virtual courses delivered in such emergencies (Affouneh, Salha, & Khlaif, 2020). A lot of time and cost is involved in online learning. It is not as easy as it seems, a considerable amount of investment is needed for getting the devices and equipment, maintaining the equipment, training the human resources, and developing the online content. Ensuring digital equity is crucial in this tough time. Bandwidth networking is required to support scientific research institutions. Owoseni and Dahunsi (2015) identify lack of adequate infrastructure on which the Internet runs such as electricity, fast Internet connectivity, backbone networks as critical barrier to online education. The Internet infrastructure are not readily available while the several technical and managerial cultures problems. According to Osuagwu, Okide, Edebatu, and Eze (2013), most internet access facilities are very slow, downloads are very difficult and takes much time which implies additional cost of application. This performance de-motivates users who need information for research but are not able to have them when they need them.
